



Bonanza Kennel Club - General Membership Meeting

January 3, 2012

The January 3, 2012, meeting of the Bonanza Kennel Club was called to order at 7:05 p.m. by President Candy Roper. The minutes of the November 1, 2011 general meeting were approved as printed in the December 2011 newsletter. **Motion**

Bob Newman, **Second** Sieg Goepner. **Motion Carried.**

The minutes of the December 8, 2011 board meeting were approved by the board as printed in the second December newsletter. **Motion** Sieg Goepner, **Second** Bob Newman. **Motion Carried.**

The **Recording** and **Corresponding** Secretaries were absent.

#### Committees:

**Show:** The judges are all hired and we're working on their assignments.

**Breed Presentation:** Cathy Coval stated that this month's presentation will be by Jessica Sage on the Bearded Collie. She asked for volunteers for future meetings stating that next month will be by Deb Schmidt on Bouviers. A request will also be placed in the newsletter for future volunteers. Cathy gave permission to publish her email and phone number in the newsletter.

**Match:** There will be a conformation B match in conjunction with Reno Kennel Club's obedience and rally B matches on January 22, 2012. Fliers were made available at the board's table. There will be day of match entries only. Carolyn asked if she should buy Best in Match (BIM) ribbons as needed to cover several matches. **Motion** Cathy Coval, **Second**, Deb Schmidt that BIM ribbons will be ordered for January 22, 2012 match as well as for future matches. In addition, existing ribbons will continue to be used until they run out to save money. **Motion Carried.**

**Nominating Committee:** Chairman Bob Kinney stated that the nominating committee will meet next week. He has contacted current board members to see if they want to continue in their current position.

**Guests:** Mary Engstrom from Lovelock is a member of Reno Kennel Club and has Fox and Rat Terriers; she filled out and submitted a membership application. Her partner, Deb Walker, who is also on the membership application, will attend next month's meeting with her. Melissa Graham is from Fallon. She has a nine year old daughter who is interested in Junior Showmanship. She currently has rescued mixed breeds but is interested in obtaining a purebred dog, and possibly raising a service dog for a Veteran. Melissa also submitted a membership application.

#### Unfinished Business:

There was supposed to be a vote on a bylaws amendment at this meeting, however, because the newsletter was not distributed within ten days of the meeting, the vote will have to be held at the February meeting.

#### New Business:

The standing rules were discussed and amendments were made to rules 2, 3, and 5. Rule 1 was clarified by a footnote to make it clear that dues will remain at current levels for 2012 until the AKC approves the pending changes to the club's bylaws.

Rule 2 was amended to include ". . . and Parliamentarian" after the words "Sergeant at Arms."

Rule 3 was amended after the word "families," to read as it appears in our premium lists and catalogs as follows: ". . . The president, show chairman, [show] hospitality chairman and members of their households will not exhibit or handle a dog at [BKC dog] shows." *Items in brackets were added for clarity.*

Rule 5 was amended to add a final sentence as follows: "Exceptions to this standing rule may be made by the board on a case-by-case basis."

**Motion** Carolyn Goepner, **Second** Nancy Gammie to accept the standing rules as amended above. **Motion carried.**

The board appointed Tony Yarbrough as Sergeant at Arms and Parliamentarian for 2012, per the 2012 Standing Rules. The position of Sergeant at Arms was questioned and it was made clear that from its inception, this position was a board appointment only.

Carolyn Goepner advised that the Bonanza Kennel Club is on the internet at some web sites and the references are unfavorable to the club. Tony Yarbrough pointed out that the words *Bonanza Kennel Club* are in the public domain on the internet and, unless we want to spend a great deal of club money to sue sites referencing the club, there is really nothing that can be done.

Cathy Coval stated that she would like assist with next year's show.

Cathy Coval asked whether the club had ever thought about doing a scholarship or to find some other use for the club's money. At the current time, the club's treasury will not support such a donation.

There being no further business, Carolyn Goepner made a **Motion** that the meeting be adjourned. Meeting adjourned at 8:11 p.m.







# ANIMAL ISSUES

## NATIONAL ANIMAL INTEREST ALLIANCE

**Wishing You a Happy and Successful New Year!**

At NAIA Trust our most important New Year's resolution is to help our constituents increase their power in 2012! This is an election year so it's doubly important to make contact with your elected officials, especially if they are up for re-election.

As a constituent, you have more influence with your elected officials than any other person or outside group, no matter how rich or seemingly powerful they might be. But for your special status to count, you must take action. As the saying goes, **the world is run by those who show up**. Our goal is to help you do that.

A few tips and tools for growth and success in 2012

1. Introduce yourself to your elected officials:

Establish a relationship;  
 Create an awareness of your issues, and  
 Become a trusted source of information.  
 Make an in-person visit, call, fax or write. If you can't personally visit Washington DC or your state capital, visit your lawmakers' local offices and get to know the staff. Share your materials with them so they become familiar with you and your issues. Phone calls can be very effective, but always follow up with a letter that puts your positions and ideas in writing. When time isn't a factor, send your letter via normal mail channels. Otherwise send it by fax or copy and paste it into your email. If you want your letter to be read, do not send it as an email attachment because security concerns may prevent it from being opened. Please read number 3 below for

guidelines on how to write the letter.

2. Use . It makes it easy for you to locate and contact your lawmakers - federal, state, and local, from the President down to your local representative. Please note that Capwiz not only gives you contact information for your lawmakers, it also provides links to federal agencies. This is valuable because under this administration federal agencies have taken a more active role, sometimes replacing legislative proposals with administrative rulemaking and other regulatory approaches. Earlier this year, for example, USDA proposed rulemaking and sought comments regarding the importation of dogs for resale. In the near future, we expect USDA to propose rulemaking and seek comments regarding the regulation of dog breeding. At that time, our members need to be prepared to make substantive comments enabling officials to write effective, well-targeted regulations that don't come with a load of unintended consequences. You can be sure that agency administrators are hearing other points of view about issues that affect you.

3. Write a short letter to introduce yourself and your issues. It's good to develop a relationship with government officials you need their help. You can be certain that representatives from other national groups have already introduced themselves. Here are a few letter-writing tips:

- \* Be respectful and polite;
  - \* Identify yourself as a voting constituent;
  - a. a stakeholder who could be affected by a policy decision;
  - b. an expert who can provide useful information on policy issues; and,
  - c. a representative of a larger group whose views you share.
- \* State your concerns very succinctly. Get to the point. Here's a reminder we have posted in the NAIA office. "Be selective. Be concise. Don't tell people what you know, tell them


what they need to know; what it means; and why it matters."

\* Provide your representative with documentation to show your expertise or prove your case whenever you can. Here are some items that dog enthusiasts can use:

- a. AKC State Economic Impact for 2010;
- b. The NAIA Shelter Project showing animal shelter ;
- c. NAIA brochures and ;
- d. NAIA Model legislation offering ; and
- e. Ask for a response to your letter, or better yet, ask for an appointment.
